**Department of Education:** Announces the availability of funding under the Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP). The GEAR UP program supports early college preparation and awareness activities for low-income students. Eligibility: (1) A State; or (2) a partnership consisting of one or more local educational agencies acting on behalf of (i) one or more elementary schools or secondary schools, and (ii) the secondary schools that students from the schools described in (i) would normally attend; (3) one or more degree granting IHE; and (4) at least two community organizations or entities, such as businesses, professional associations, community-based organizations, philanthropic organizations and State agencies. **Department of Education:** Announces the availability of funding under the Business and International Education program. The program provides grants to enhance international business education programs and to expand the capacity of the business community to engage in international economic activities. Eligibility: Institutions of higher education that have entered into agreements with business enterprises, trade organizations, or associations that are engaged in international economic activity—or a combination or consortium of these enterprises, organizations, or associations—for the purposes of pursuing the activities authorized under this program. **Department of Justice:** Announces the availability of funding under the Gang Resistance Education and Training (G.R.E.A.T.) Program. The program is a school-based, law enforcement officer-instructed classroom curriculum administered by the Office of Justice Programs' Bureau of Justice Assistance in cooperation with the Department of Justice's Bureau of Alcohol, Tobacco, Firearms and Explosives. The program's primary objective is prevention and is intended as immunization against delinquency, youth violence, and gang membership. G.R.E.A.T. lessons focus on providing life skills to students to help them avoid engaging in delinquent behavior and violence to solve problems. Criminal justice professionals with powers of arrest—police officers, sheriff's deputies, parole or probation officers, school police officers, federal law enforcement officers/agents, prosecutors, judges, court officials, district attorneys—are eligible to teach G.R.E.A.T. Eligibility: Any state, local, or tribal jurisdiction or law enforcement agency (including school police, housing authority police, prosecution, probation, and parole agencies possessing the power of arrest) with an active G.R.E.A.T. Program, or

committed to starting a G.R.E.A.T. Program, in cooperation with a local education agency, is eligible to apply for funding. Deadline: December 13, 2007. **Department of Health Resources and Service Administration:** Announces the availability of funding under the Minority Faculty Fellowship Program. These grants increase the number of under represented minority individuals who are members of the faculty in a health profession school. The grants enable schools to provide a stipend and a training allowance to the faculty fellow. Grantees must: (1) Identify, recruit and select individuals who are underrepresented racial minorities in the health professions for teaching, administration, or research positions at a health professions institution; (2) Provide such individuals with the skills necessary for tenured faculty positions, which may include training in pedagogy, program administration, design and conduct of research, grant writing, and the preparation of articles suitable for publication in peer review journals; (3) Assist individuals in preparation for an academic career by providing services such as counseling; and (4) Provide health services to rural or medically underserved populations. Eligibility: eligible applicants are accredited health professions schools of allopathic and osteopathic medicine, nursing, dentistry, veterinary medicine, optometry, allied health, public health, podiatric medicine, pharmacy, and schools offering graduate programs in

**New York Department of Education:** Announces the availability of funding for projects that focus on activities that document life in New York State. 1) Projects to identify, survey and plan for the systematic collection of records relating to underdocumented subjects, institutions or activities, particularly education policy; impact of the World Trade Center attacks; New York's changing industries and new population groups; as well as mental health activities and environmental affairs. 2) Projects to arrange and describe historical records already in repositories or community organizations. 3) Projects to develop strategic plans for historical records repositories or not-for-profit community organizations. 4) Projects for regional documentation planning to identify under-documented topics or activities. **New York Department of State:** The Department of State is soliciting applications from local governments for matching grants available under Title 11 of the Environmental Protection Fund

(EPF) for local waterfront revitalization projects. **New York Department of Health:** Applications for grants are now being accepted to support community-based programs that provide uninsured and underinsured men and women in New York State (NYS) with routine screening for breast, cervical and colorectal cancer, with the overall goal of reducing the mortality rates for these diseases in NYS. These community-based programs (known as Cancer Services Program partnerships, or CSP partnerships) will coordinate recruitment for and provision of comprehensive, age-appropriate breast, cervical and colorectal cancer screening services, follow-up care and other related services to eligible men and women. Eligible applicants are health departments and incorporated, not-for-profit organizations, which may include community-based organizations, hospitals, health care facilities, and health maintenance organizations. **New York Department of Environmental Conservation:** Funds are available to obtain independent technical assistance about State Superfund Program and Brownfield Cleanup Program sites that pose a significant threat to public health or the environment. A qualifying group must certify that its membership represents the interest of the community affected by the site, and that its members' health, economic well-being or enjoyment of the environment, are potentially threatened by the site. Portions of technical assistance work may be subcontracted based on unit price bids/quotes for professional services to subconsultants, subject to the guidance from and approval of the Department. The TAG recipient and its contractors must make good faith efforts to subcontract a portion of the contract amount to Minority and Women Owned Business Enterprises (M/WBE). The percentage goals for MBE and WBE participation are 8.8% for equipment, supplies and services in the Upstate NYSDEC Regions 3-9. For New York City and Long Island NYSDEC Regions 1 & 2, MBE utilization goal percentages are 18.8% for equipment, supplies and services; for WBE these goal percentages are 20.5% for equipment, supplies and services. The TAG recipient and its contractors must make good faith efforts to employ 10% minority group members and 10% women for a portion of the workforce hours required to perform the work under this contract. Eligibility: Eligible community groups must be non-responsible parties incorporated as not-for-profit corporations under section 501(c)(3) of the Internal Revenue Code. **New York Department of Environmental Conservation:** This notice is to advertise the availability of State assistance funding to municipalities for Environmental Restoration Projects to investigate and/or remediate hazardous substances on property held in title by a municipality.

A municipality may obtain “temporary incidents of ownership” during a tax foreclosure proceeding for a property in order to conduct such investigations. Portions of investigation and remediation activities may be subcontracted based on unit price bids/quotes for professional services to subconsultants, subject to guidance from and approval of the Department. The recipient and its contractors must make good faith efforts to subcontract a portion of the contract amount to Minority and Women Owned Business Enterprises (M/WBE). The percentage goals for MBE and WBE participation are 8.8% for equipment, supplies and services, and 6% for construction in the Upstate NYSDEC Regions 3-9. For New York City and Long Island NYSDEC Regions 1 & 2, MBE utilization goal percentages are 18.8% for equipment, supplies and services and 21.5% for construction. WBE goal percentages are 20.5% for equipment, supplies and services, and 13.7% for construction for New York City and Long Island. The recipient and its contractors must make good faith efforts to employ 10% minority group members and 10% women for a portion of the workforce hours required to perform the work under this contract. Eligibility: A local public authority or public benefit corporation, county, city, town, village, school district, supervisory district, district corporation, improvement district within a county, city, town or village, or Indian nation or tribe recognized by the State and the U.S. within a reservation wholly or partly within NY State boundaries, or any combination thereof.
